Overview

Beginning with tax year 2010, employees can view and print their W-2 Forms from a PDF file in EMACS Self Service. The PDF version contains the same information as the paper W-2 mailed to you in January.

If you need a copy of a W-2 Form for years 2009 and prior, you must continue to complete the 'W-2 Request for Duplicate' form available on the EMACS website or from your Departmental Payroll Specialist.

Click on the '**Year End Form**' link. A new window will open displaying a PDF copy of your W-2. If you have problems viewing your W-2, press and hold down the 'Ctrl' button on your keyboard before clicking on the link. Only the current year W-2 Form will be visible from this screen. To view a W-2 from a previous year click on the '**View a Different Tax Year**' link.
